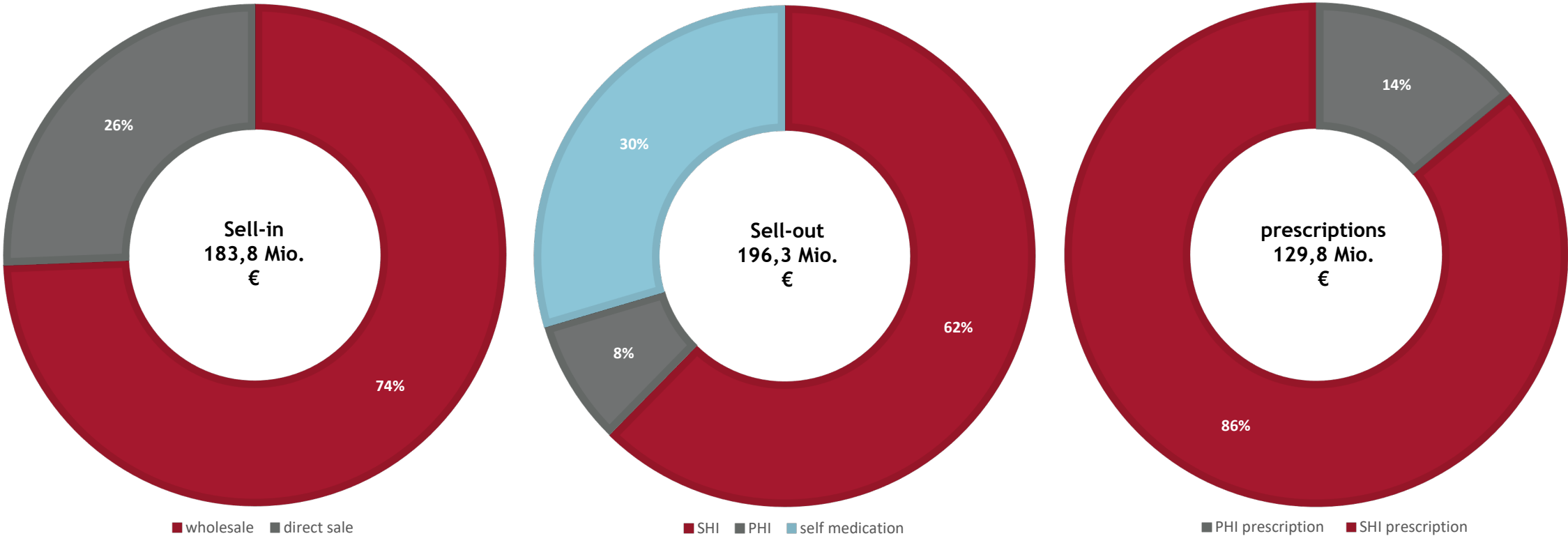




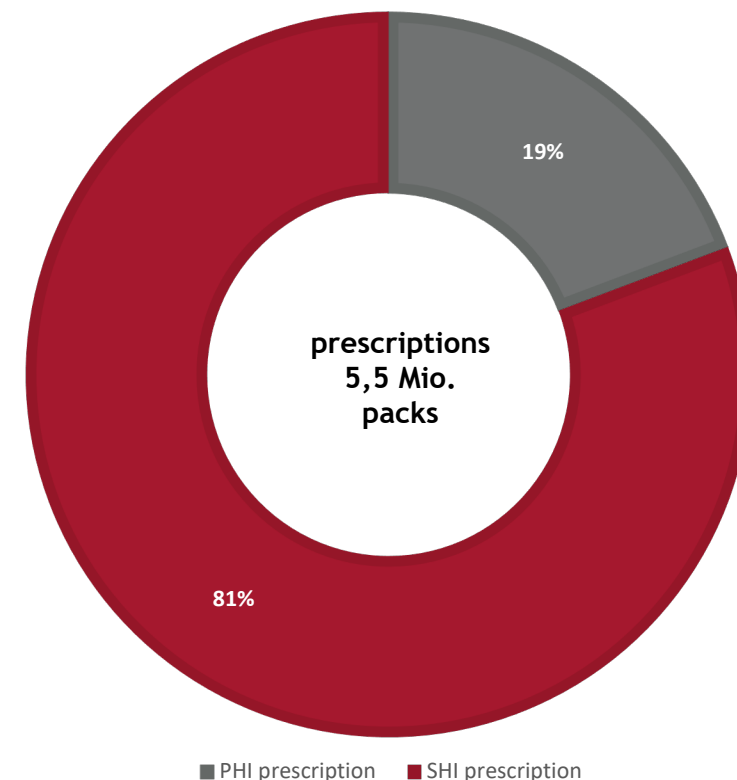
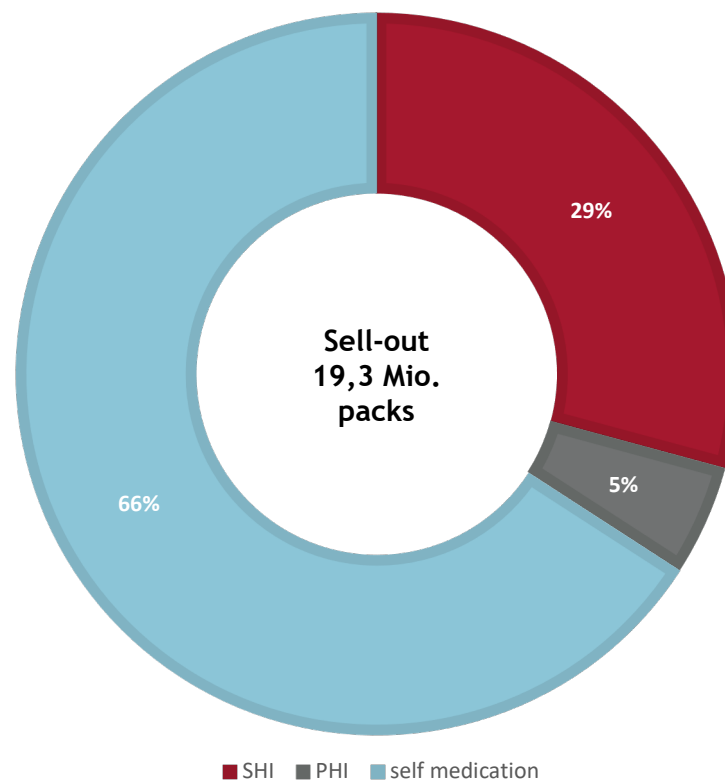
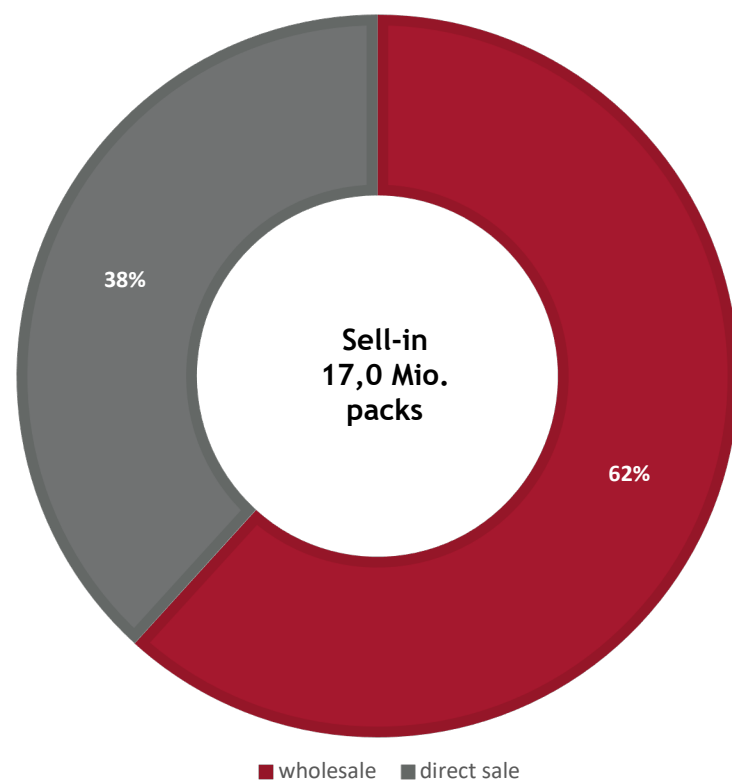

# Pharmacy market December 2023 based on volume ApU €



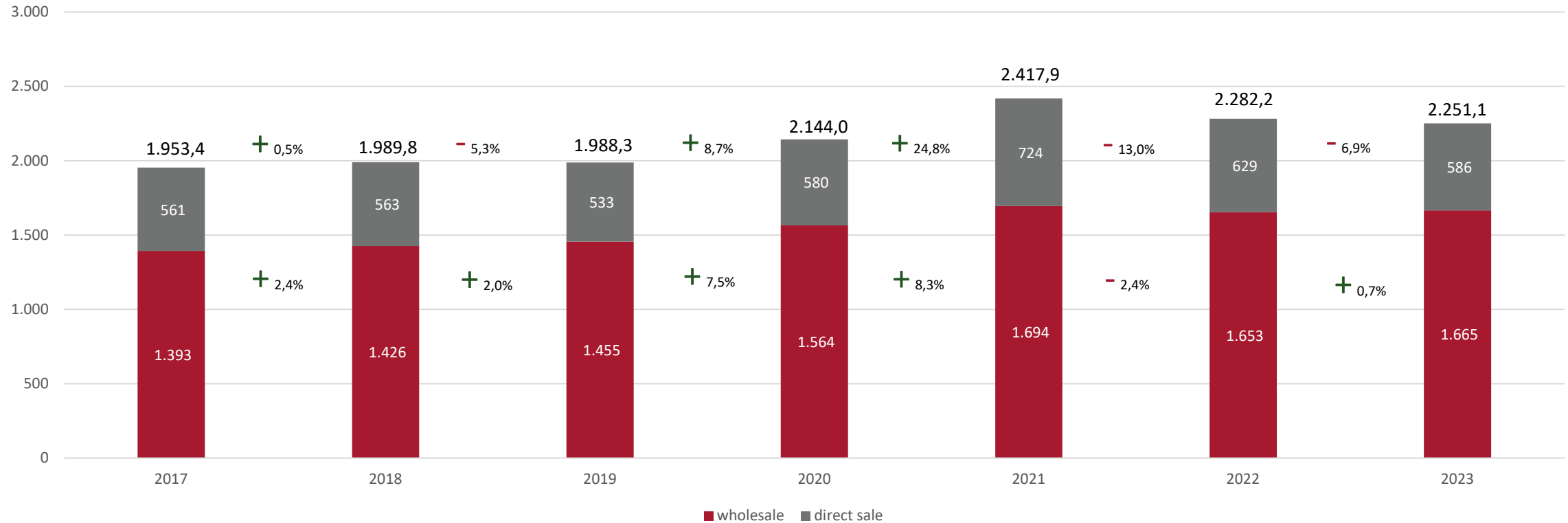

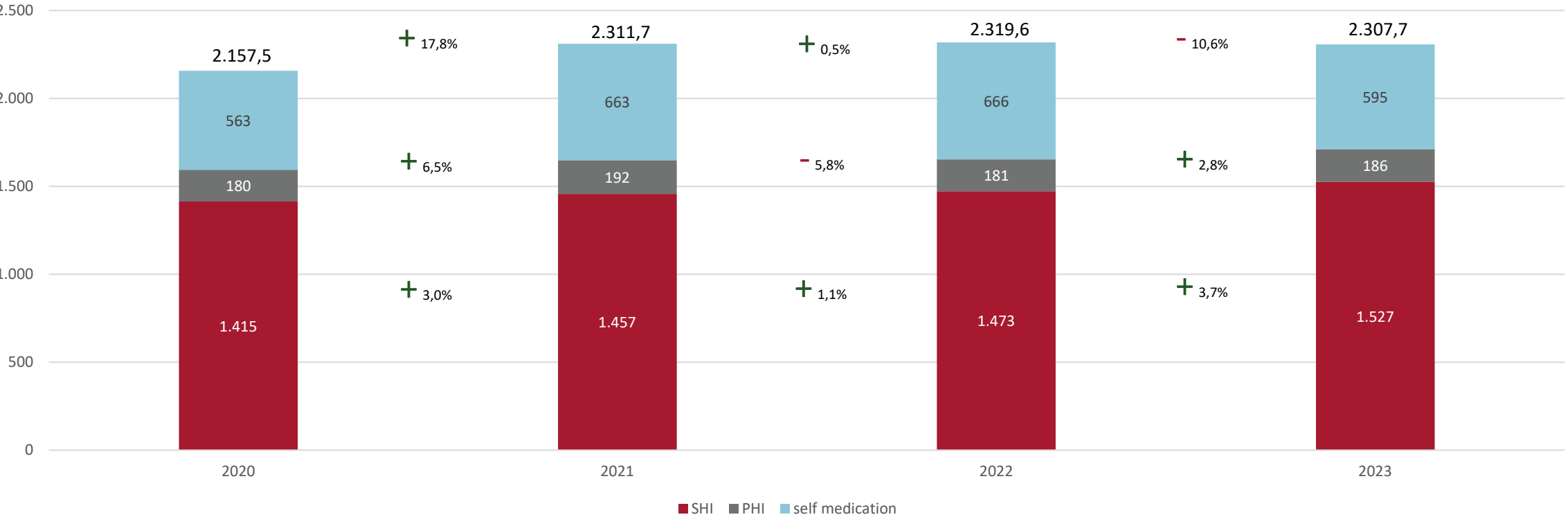

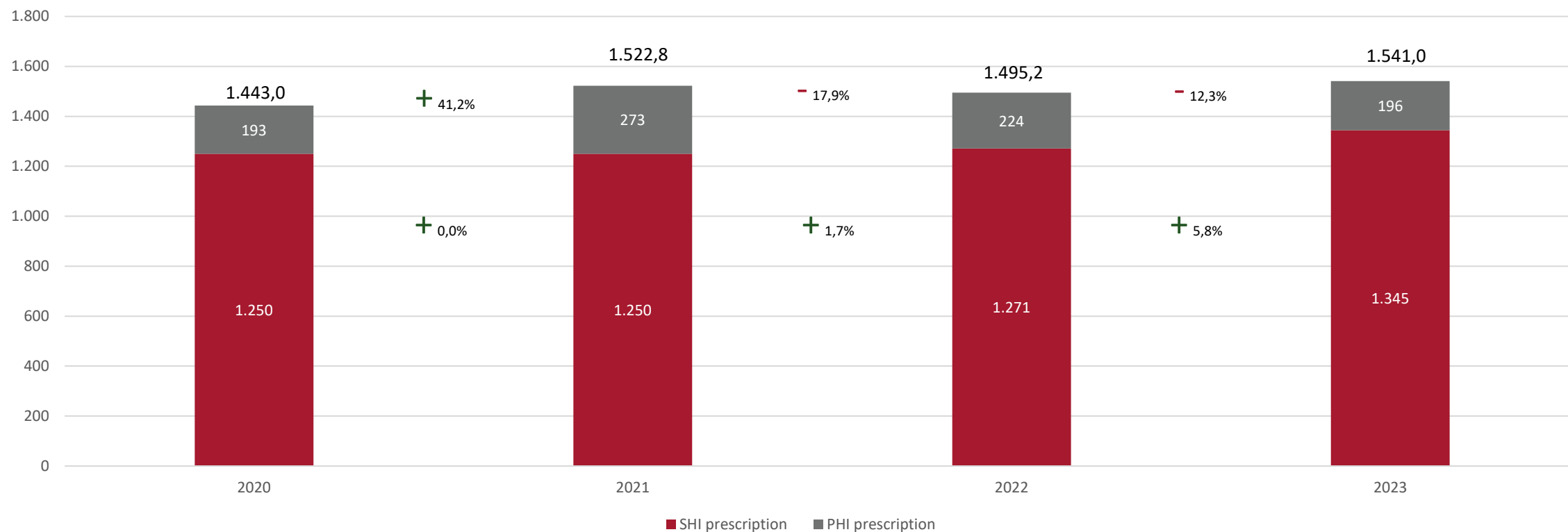
# Medical supply market development Pharmacy Sell-out

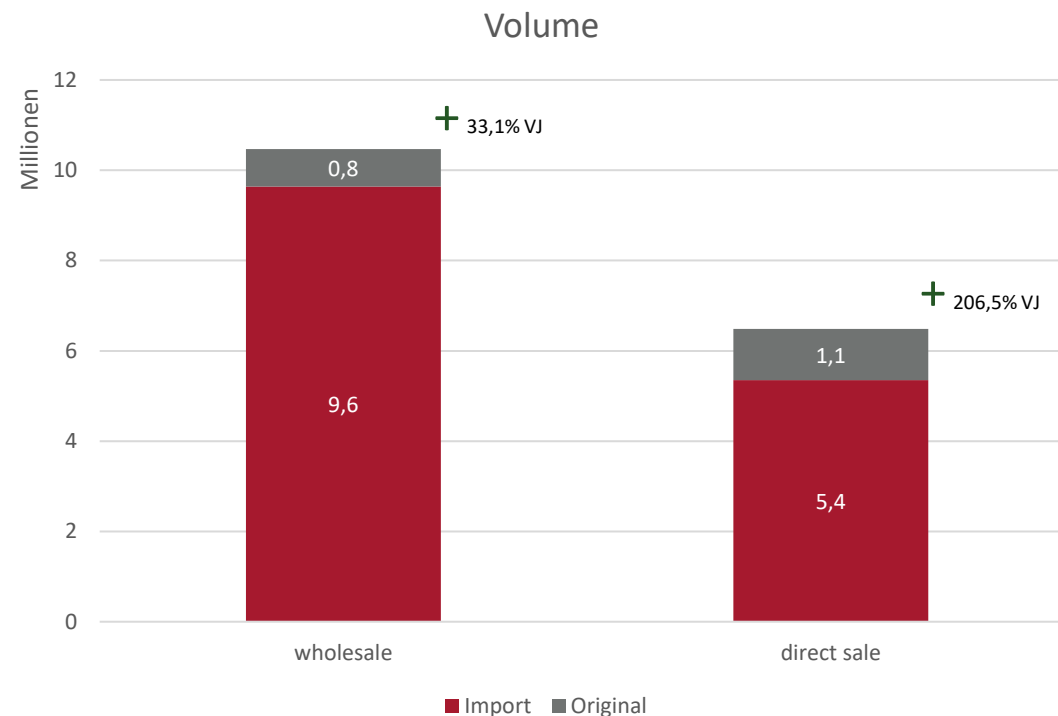
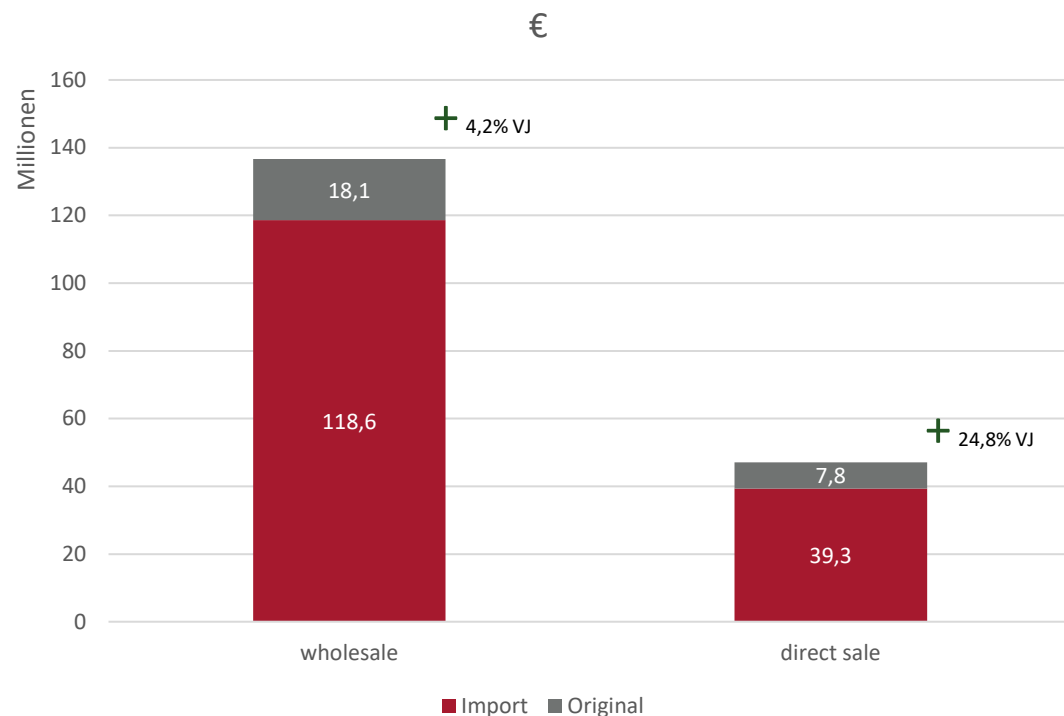

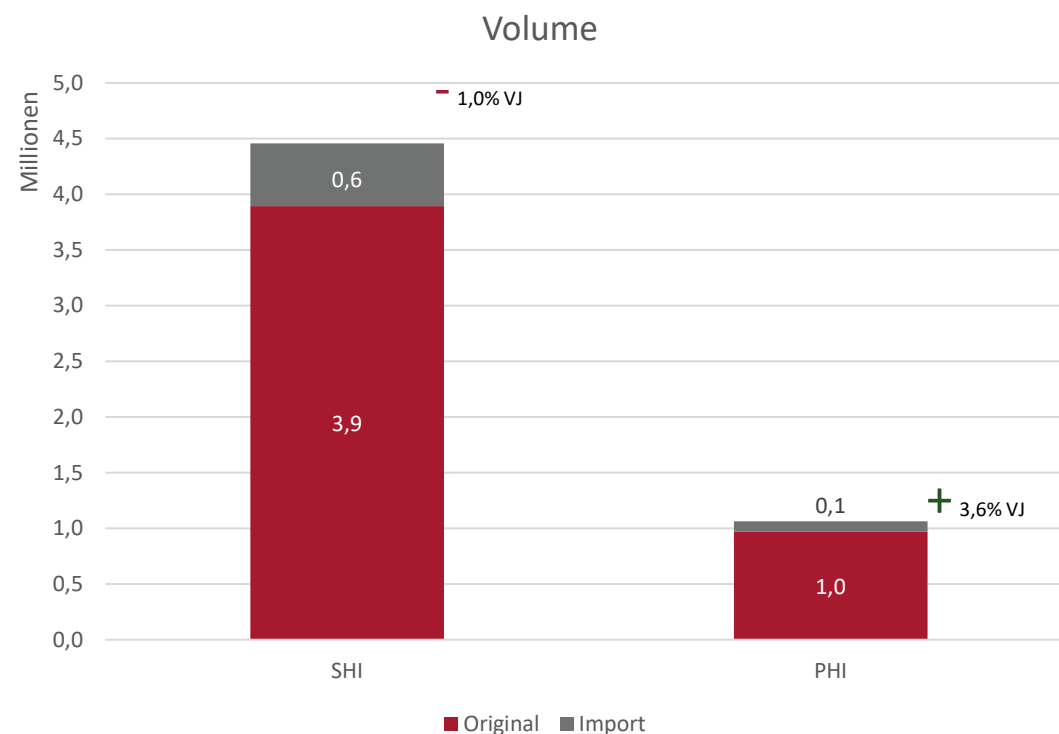
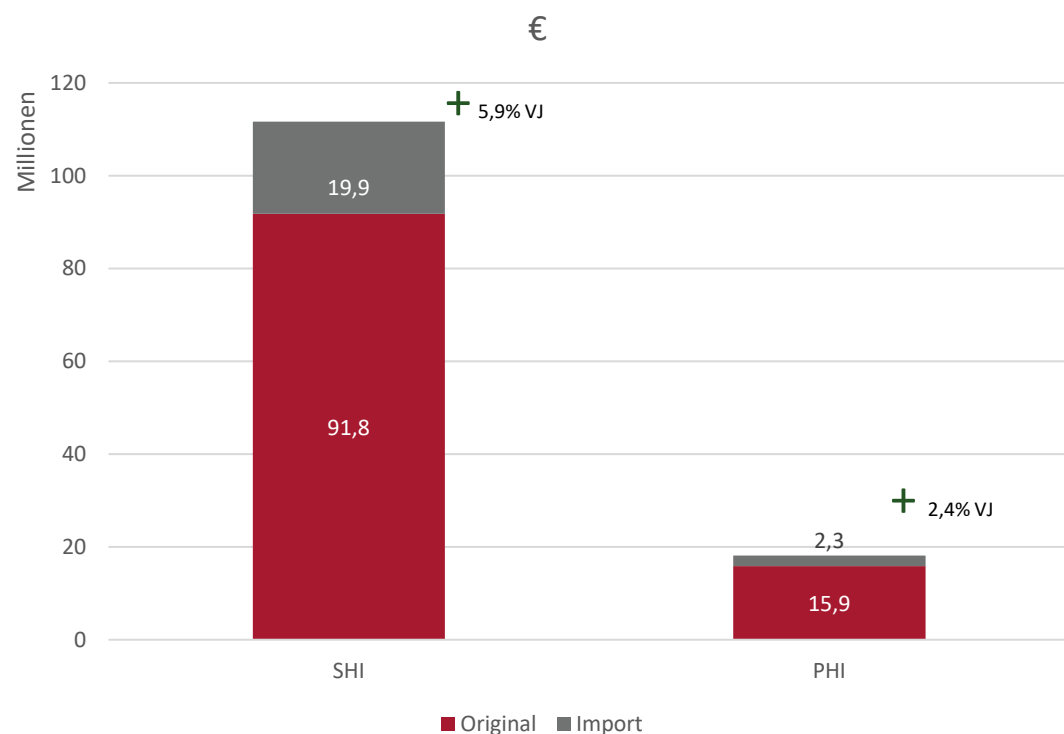
# Original vs. Import products pharmacy Sell-in December 2023
